

GUIDELINES ON HOW TO FILL UP DAGANG NET REGISTRATION FORM

Section A – Company Information

- i. Contact Person for EDI System
He/She is responsible for Dagang Net system used by your company.
- ii. Company Name, Co. ROC/ROB No, Telephone No, Agent Code, H/P No and Email Address
Your company details and correspondence is required for Dagang Net to process your application.

Section B – Address

- iii. Company Address (ROC Registered Address), Telephone No & Fax No
Item No (ii) information MUST be the same as your Co. ROC/ROB No.
- iv. Billing Address, Telephone No & Fax No
If your billing address is different from item No (ii or iii), please fill in the address.
- v. Installation Address
This information is required for Dagang Net Customs Declaration software (eDeclare).

Section C – Community

- vi. This section is to be tick (v) to determine the area where your customs declaration is made. For example, if your declaration is based at Port Klang, please tick PKCS as shown in the sample below
- vii. Note: For Permit application to other Government Agencies, please specify the name of the agency. For example, if you are applying for permit from MITI, please fill in under Other Government Agencies as shown in the sample below

Section D - Connectivity

- viii. This section is to be tick (v) to determine your internet service provider. For example, if you are a TM Net user, please tick (v) TM Net as shown in the sample below.

Section E – Purchasing Items

- ix. This section is to be tick (v) to determine the Dagang Net services which you want to subscribe. For example, you subscribe to eDeclare Customs Declarations Package (Modules: K1, K1A, K2, K3, K8, K9 and EFT) and additional requirement – Mailbox, please tick (v) the items in their respective box as shown in the sample below.
