CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) ORDER 2018

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) Order 2018**.

(2) This Order comes into operation on 1 March 2018.
