- **COMPANY MAY APPLY CO (FORM E) BY USING EXISTING APPROVED CA AS USUAL (REMINDER: APPROVED CO MUST BE PRINTED ON THE FMM PRE-PRINTED FORM E);**
- **ALL NEW CA SUBMISSION FROM 27 JULY 2019 WILL CONTINUE TO BE EVALUATED AND APPROVED UNDER THE CURRENT RULES OF ORIGIN;**
- **COMPANY WISHING TO APPLY CA UNDER THE NEW RULES OF ORIGIN MAY PROCEED TO DO SO BY PUTTING A REMARK (NEW RULES OR OLD RULES) IN THE TRADER'S REMARK SECTION. HOWEVER, BE ADVISED THAT APPROVAL FOR CA UNDER THE NEW RULES OF ORIGIN WILL ONLY BE GIVEN AFTER THE NEW RULES OF ORIGIN ENTERED INTO FORCE OR ANY OTHER DATE THAT WILL BE NOTIFIED LATER.**

FURTHER UPDATES ON THE IMPLEMENTATION WILL BE CONVEYED SOON. WE REGRET ANY INCONVENIENCE CAUSED AND WE APPRECIATE YOUR UNDERSTANDING IN THIS MATTER.
