WE ARE PLEASED TO INFORM THAT THE IMPLEMENTATION OF REGISTERED EXPORTER (REX) SYSTEM UNDER GENERALIZED SYSTEM OF PREFERENCES (GSP) NORWAY AND SWITZERLAND WILL COMMENCE EFFECTIVE ON **1 JULY 2020**.

IN LINE WITH THIS DEVELOPMENT, EXPORTERS ARE REQUIRED TO PRESENT A **SELF-DECLARATION STATEMENT ON ORIGIN (SOO)** MADE OUT ON INVOICE OR COMMERCIAL DOCUMENTS AS A PROOF OF ORIGIN FOR EXPORTATION OF GOODS FROM MALAYSIA TO NORWAY AND SWITZERLAND. MITI WILL NO LONGER ISSUE THE CERTIFICATE OF ORIGIN FORM A FOR ABOVE-MENTIONED COUNTRIES EFFECTIVELY FROM **15 JUNE 2020**. HOWEVER ISSUANCE OF GSP FORM A IS REMAINED FOR EXPORTATION TO ICELAND, LIECHTENSTEIN, BELARUS, KAZAKHSTAN AND RUSSIA.
