[UPDATES] IMPLEMENTATION OF REGISTERED EXPORTER (REX) SYSTEM UNDER GENERALIZED SYSTEM OF PREFERENCES (GSP) NORWAY AND SWITZERLAND (INCLUSIVE LIECHTENSTEIN)

Pursuant to the implementation of Registered Exporter (REX) System under Generalized System of Preferences (GSP) Norway and Switzerland (inclusive Liechtenstein) which will commence effective on **1 July 2020**, we wish to update on **important dates related to application of GSP Form A via ePCO System.**

- MITI will no longer issue GSP Form A for exportation to Norway and Switzerland (inclusive Liechtenstein) starting **15 June 2020 (Monday).**
- Final date submission of Form A: 11 June 2020 (Thursday).
- Final date resubmission of Form A (after queried): 14 June 2020 (Sunday).
- Final approval of Form A: 14 June 2020 (Sunday).
- Submission/Resubmission of application Form A after abovementioned dates will be rejected.
- Starting **1 July 2020**, Norway and Switzerland (inclusive Liechtenstein) authorities will only accept declaration of **Statement on Origin (SOO) for GSP and no longer accept hardcopy Form A.**
- Each company is required to present self-declaration SOO based on the Origin Criteria from GSP Cost Analysis (CA) approved by MITI via ePCO System.

[PERINGATAN] PELAKSANAAN SISTEM *REGISTERED EXPORTER (REX)* DI BAWAH *GENERALIZED SYSTEM OF PREFERENCES (GSP)* NORWAY DAN SWITZERLAND (TERMASUK LIECHTENSTEIN)

Lanjutan daripada pelaksanaan sistem *Registered Exporter (REX)* di bawah *Generalized System of Preferences (GSP)* Norway dan Switzerland (termasuk Liechtenstein) yang akan bermula pada **1 Julai 2020**, MITI ingin memaklumkan **tarikh-tarikh penting berkenaan permohonan Borang A GSP melalui sistem ePCO**.

- Mulai **15 Jun 2020 (Isnin)**, MITI tidak akan mengeluarkan Borang A GSP bagi pengeksporan ke Norway dan Switzerland (termasuk Liechtenstein).
- Tarikh akhir permohonan Borang A: **11 Jun 2020 (Khamis)**.
- Tarikh akhir resubmission (selepas kuiiri) Borang A: **14 Jun 2020 (Ahad)**.
- Tarikh akhir kelulusan Borang A: **14 Jun 2020 (Ahad)**.
- Permohonan/Resubmission Borang A selepas tarikh-tarikh di atas akan ditolak.
- Mulai 1 Julai 2020, pihak berkuasa Norway dan Switzerland (termasuk Liechtenstein) hanya akan menerima deklarasi **Statement on Origin (SOO)** bagi GSP dan tidak akan menerima Borang A.
- Pengeksport hendaklah mengemukakan deklarasi *Statement on Origin (SOO)* berdasarkan Kriteria Tempasal daripada Analisa Kos GSP yang diluluskan oleh MITI melalui sistem ePCO.
